TERMS & CONDITIONS

WIN A TRIP TO JAPAN IN 2025 PROMOTION GOLD EDUCATIONAL TOURS PTY LTD

1. GENERAL PROVISIONS

1.1 These Terms and Conditions ("Terms") govern the Win A Trip to Japan promotion ("Promotion") conducted by Gold Educational Tours (GET) Pty Ltd (ABN 41 659 076 365) of Level 1, 4 Money Street, Perth WA 6000 ("Promoter").

1.2 The Promotion will be conducted online through the Promoter's website, social media channels (Facebook and Instagram) direct email and other promotional tools.

1.3 The Promotion commences at 09:00 AWST on Tuesday, 13 January 2025 and concludes at 17:00 AWST on Monday, 15 December 2025 ("Promotional Period").

2. ELIGIBILITY

2.1 Entry is open to GET registered host families ("Eligible Entrants").

2.2 The following persons are ineligible to enter:

- Employees of the Promoter;
- Agents, affiliates, and immediate family members of the Promoter.

2.3 To enter, eligible entrants must successfully complete a Hosting Program for Japanese students through GET's homestay program during the Promotional Period.

2.4 Successful completion of the program requires: (a) Hosting one or more Japanese students for the full and continuous duration of the designated GET program; (b) Providing continuous accommodation and care for the entire program duration as specified by GET; (c) For example, if a program lasts eleven (11) nights, the student(s) must be hosted for the entire eleven (11) consecutive nights without interruption.

2.5 Entry allocation:

- One (1) entry will be awarded per hosting program completed.
- Hosting multiple students simultaneously constitutes one (1) entry.
- Multiple entries are permitted through completion of multiple hosting programs.

2.6 By successfully completing a full hosting programme ("Eligible programme"), host families will be automatically entered into the [**Win a Trip to Japan in 2025**] ("Competition").

2.7 No purchase or payment is required to enter the Promotion.

4. PRIZE

4.1 The total prize pool is valued up to AUD\$10,000 (inclusive of GST) comprising:

- Up to four (4) economy class return airfare tickets from Perth to Tokyo (Narita or Haneda airports), valued up to AUD\$1,500 per ticket.
- Seven (7) nights accommodation in two (2) twin rooms at a 4-star hotel within the Tokyo metropolitan area, valued up to AUD\$4,000.
- No additional services, benefits, or inclusions beyond those specified in clause 4.1 shall be deemed part of this Agreement;

4.2 Prize Conditions:

- The prize is non-transferable, non-refundable, and cannot be exchanged for cash.
- Hotel and airline selection is at the Promoter's sole discretion.

5. WINNER DETERMINATION

5.1 The winner will be determined by a random draw in person conducted between 09:00 and 17:00 AWST on Tuesday, 16 December 2025 at Level 1, 4 Money Street, Perth WA 6000.

5.2 The draw will be filmed and supervised by an independent observer. Audit records can be made available to an authorised officer or member of the Police Force on request.

5.3 The winner will be:

- Notified via email or phone call within two (2) business days of the draw.
- Required to present valid photo identification for verification.

5.4 The winner agrees to: a) Attend a commercial photo shoot at Gold Educational Tours' office ("GET office") at a mutually agreed time; b) Participate in all reasonable promotional activities as requested by Gold Educational Tours ("the Promoter"); and c) Grant the Promoter permission to use any photographs, video, or other material ("Content") created during the photo shoot.

6. PRIZE REDEMPTION

6.1 The winner must claim the prize within fourteen (14) days of notification.

6.2 Travel booking requirements:

- Travel dates must be submitted no less than 6 months in advance.
- Travel is not permitted during the following blackout periods:
 - Golden Week (28 April - 6 May);
 - Obon Festival (12-16 August);
 - Christmas-New Year period (23 December - 3 January).

6.3 The prize will be redrawn if:

- The winner fails to claim the prize within the specified period.
- Suitable travel dates cannot be agreed upon.

7. TRAVEL REQUIREMENTS

7.1 All travellers must possess valid passports with a minimum of six (6) months validity beyond the return date.

7.2 The winner and their guests are solely responsible for obtaining and maintaining all required travel documentation.

8. DATA PRIVACY

8.1 The Promoter will collect personal information (name, email address, etc.) from entrants solely for the purpose of administering the Promotion and contacting the winner.

8.2 The Promoter will collect, store, use, and handle all personal information provided by entrants in accordance with its [Privacy Policy](#).

9. FORCE MAJEURE

9.1 The Promoter will not be liable for any delay or failure to perform its obligations under these Terms due to any event beyond its reasonable control, including but not limited to acts of God, natural disasters, war, terrorism, pandemics, or government regulations.

10. DISPUTE RESOLUTION

10.1 Any dispute arising out of or in connection with these Terms will be attempted to be resolved amicably between the parties.

10.2 If the parties are unable to reach a resolution, the dispute will be referred to mediation in accordance with the laws of Western Australia.

11. LEGAL COMPLIANCE

11.1 This Promotion is conducted in accordance with the Gaming and Wagering Commission Act 1987 (WA) and Gaming and Wagering Commission Regulation 36A.

11.2 All Promotion records will be maintained for twelve (12) months from the winner announcement date and will be available upon request.

12. GENERAL CONDITIONS

12.1 By entering, winners consent to the use of their name, image, and trip footage for promotional purposes.

12.2 The Promoter reserves the right to:

- Modify or cancel the Promotion, subject to regulatory approval.
- Disqualify entries involving fraud or rule violations.

12.3 The Promoter accepts no liability for any loss or injury related to participation in the Promotion.

12.4 These Terms are governed by the laws of Western Australia, and entrants submit to the exclusive jurisdiction of the courts of Western Australia.
